REMITS TO NZ BRANCH AGM

 Remit 1 – Removal of Membership, Communication & Publicity Coordinator (MCPC) Position (Andrew Patterson)

Proposal

The structure of the Branch Management Committee should be rationalised with the removal of the position of Membership, Communications and Publicity Co-ordinator (MCPC).

Rationale

Each Region already has responsibility for the promotion of SCD generally, and the RSCDS in particular, within its local area. There is little evidence that the Branch MCPC is effective in the promotion of SCD within NZ as a whole, whereas each Region is able to tailor its promotional activities to the specific needs of clubs and dancers within its area. The effect of this proposal will be to:

- Eliminate duplication of effort between Branch and Region.
- Streamline processes by ensuring that the activities are directly relevant to the membership.
- Create a structure which more closely reflects what happens in practice.

The primary **Membership** responsibility of the MCPC is the collection of annual subscriptions but, in practice, this task is delegated to the Regions who only need to be told (by the Branch Treasurer) the fee rates for the year. Each Region already maintains an accurate membership list and the current practice of Excel workbook distribution is cumbersome, time-consuming and unnecessary. Having collected the fees and returned them to

the Branch Treasurer, each Region need only provide the Branch with a list of members (Added, Renewed, Deleted) in an agreed format. Note that the task of maintaining the membership database has already been transferred to the new role of Information Technology Co-ordinator.

The primary **Communications and Publicity** responsibility of the MCPC is not immediately apparent but, until recently, the major strategic role was to co-ordinate the maintenance and development of the Branch website. Responsibility for this has now been transferred to the new role of Information Technology Coordinator.

The few remaining activities of the MCPC are intermittent in nature and hardly justify an executive position on the Management Committee. This is an opportunity to reassess the need for these activities and, where necessary, allocate them to appropriate members of the Management Committee. For example, MAC News could be taken over by the editor of Kiwi News (with which it has been incorporated in recent years). Membership reporting should be a simple matter of the IT Coordinator running reports against the database. The distribution of publicity material originating from RSCDS Headquarters in Edinburgh would be a very minor addition to the workload of the Branch Secretary or the process could be streamlined further if Regions were to submit requests for such material direct to RSCDS Headquarters.

Discussion:

- Do these positions finance anything?
- How do we get money from NZ Branch?
- What does the Branch do to help Regions increase membership? They help by financing, but not activities. Regions have to do the actual work.
- There still has been no response from NZ Branch membership coordinator about New Members' Packs.
 RSCDS does respond, and quickly sends out their packs. New members appreciate receiving something.
- Both Communication & Publicity and Membership Coordinators could not input data into the database, which is one of the reasons why an IT Coordinator role was created. There will now be an IT Coordinator and an IT Advisor (Duncan Laidlaw had already been appointed by Management Committee last year – this is not a MC role).

✓ Remit 2 – Removal of Vice President Position

(Bill Jacob)

Proposal

That the Constitution of the NZ Branch be amended to remove the position of Vice President and re-distribute allocated tasks to other Management Committee roles.

Rationale

The current practice of appointing a Vice President to be a 'President-in-waiting' and be from the 'other' island to maintain a cycle of North Island/South Island rotation is an unnecessary drain on finances. It is just not necessary for a President-in-waiting to be 'in training' for up to 4 years. NZ Branch has within its ranks, plenty of experience in Management Committee functions who could step into the position of President or recommend someone who is suitable (by a vote at AGM) or in the event that the current President is unable to complete his/her 4 year term (by Management Committee appointment). All nominations for President should be considered on their merit without undue precedence being given to a single individual just because he/she has been waiting to step in for up to 4 years.

The current Job Description for Vice President is essentially a space-filler with mostly unnecessary tasks or those that can be done by other Management Committee roles.

Whenever the President cannot be in attendance, and a Vice President would normally deputise, there is no reason why another member of Management Committee can't be delegated the task. It is quite normal for Management Committee members to be scattered around the country, they could easily deputise and that would avoid unnecessary travel by the President. Also, at any meeting, it is normal business practice for those present to appoint a Chairman for the purposes of running the meeting.

We do not appoint a Vice-Secretary or Vice-Treasurer, yet the continuity and hand-over of these roles is crucial to the functioning of the Management Committee, whereas the same cannot be said of the President who is more of a figurehead who needs to maintain an overview of those who carry out the 'real' work of the Branch.

The current tasks allocated to the Vice President can be reallocated to existing roles:

... Managing the appointment of Shopkeepers: President.

...Review and update The Guidelines: Secretary. This is an on-going function based on decisions made at meetings, which the Secretary is always directly involved in via minutes. On the in-frequent occasion that a complete re-vamp of the documentation is necessary, this task can be delegated to an appropriate person expressly appointed.

Bill Jacob then made an amendment to the motion to insert: "To have a President-Elect for one year prior" *Discussion:*

- There is no Vice President this year anyway.
- There are few enough people wanting to stand for Management Committee already.
- \circ $\;$ A large expense for VP to attend Summer School to do nothing.
- \circ $\;$ The VP's only role is to update the Guidelines. Someone else could do that job.
- There could be more work for less people.
- Remember a little while back the Secretary took over most jobs in the Management Committee. We do not want that to happen again.

Moved that the amendment be deleted, and return to the original Remit.

✓ Remit 3 – Establishment of Dance Scottish Clubs in all NZ Universities within next 3 years (Wayne McConnel)

Proposal

That NZ Branch aim to establish Dance Scottish Clubs at all NZ Universities within the next three years. *Rationale*

The role of NZ Branch would be to maintain contact with young dancers who go to university and encourage the establishment of clubs by providing access to:

- Recorded music
- Dance books
- Local resources including:
 - > experienced dance teachers as mentors
 - > music systems
 - Suitable dance halls / venues

Through establishing a small number of clubs run by and for young dancers, they can enjoy the exhilaration and excitement of energetic dancing that attracted most of us to Scottish country dance in the past.

Within universities there are facilities and financial support available for clubs with 10 or more student members.

Moved that: Remit 3 (That NZ Branch aim to establish Dance Scottish Clubs at all NZ Universities within the next three years) be approved.

✓ Remit 4 – Individual Voting Entitlement

(Antanas Procuta)

Proposal

That the Constitution of the RSCDS NZ Branch be amended so:

- a) that at all General Meetings of the NZ Branch of the RSCDS each financial member, except those whose subscriptions are in arrears, is entitled to one vote on any motion before the meeting. A member may provide a postal vote or an electronic vote, or hold proxy votes, on any item of business where notice was given in accordance with the provisions of Clause 8.6, and that
- b) correspondingly, all current clauses related to regional-based delegate voting on behalf of members are deleted or amended to reflect that each member is responsible for the allocation of their own vote.

Rationale

The above is proposed:

- a) To bring voting entitlement to accord with the current RSCDS 'Model Constitution for Local Association of Members' (Branches), available on the Society website,
- b) To align with voting entitlement at RSCDS NZ regional level (Clause 5.4).
- c) To facilitate and encourage better and direct engagement of RSCDS NZ Branch members with the objectives, business and well-being of the New Zealand branch, and
- d) To recognise that the financial members of the society are entitled to use their vote on matters before General Meetings as they see fit. It may be viewed that in the 'internet era' delegate-based voting is somewhat archaic, and to a certain extent, removed from democratic participation.

Proposed clause changes in accord with the above proposed remit (draft):

- ADD at end of clause: "For the purpose of clarification, a Junior Associate over the age Clause 2.1 (2) of 16 - if also a member of the Society – is considered a voting member of the branch.
- Clause 2.3 (2) (ii) DELETE
- Clause 2.3 (2) (iii) DELETE DELETE
- Clause 5.5
- Clause 8.3 (1) DELETE, and REPLACE WITH

"At any General Meetings of the NZ Branch of the RSCDS each financial member, except those whose subscriptions are in arrears, is entitled to one vote on any motion before the meeting. A member may provide a postal vote or an electronic vote, or hold proxy votes, on any item of business where notice was given in accordance with the provisions of Clause 8.6"

- Clause 8.3 (2) DELETE
- Clause 8.3 (3) DFI FTF
- Clause 8.3 (4) RE-NUMBER TO BE Clause 8.3 (2)
- Clause 8.4 DELETE, and REPLACE WITH

"One-quarter of the members entitled to vote or twenty-five members of the Branch entitled to vote, whichever shall be the lesser, shall constitute a quorum."

Moved that: Remit 4 (That the Constitution of the RSCDS NZ Branch be amended so that at all General Meetings of the NZ Branch of the RSCDS each financial member, except those whose subscriptions are in arrears, is entitled to one vote on any motion before the meeting) be approved.

Moved: Antanas Procuta/Ian Stewart/ Carried

Discussion:

- How does it work in the real world? Instead of delegates with proxies, it will be individual members who 0 have extra votes. You can sway people at the meeting by the discussions held. How will individual members know which way their proxies would vote on the day?
- Proxy votes can be changed if permission is given by the vote holder would have to be done prior to 0 meeting.
- Pre-determined voting whichever way we go.
- Are we making the process less robust? 0
- Online voting is easy with one person/one vote working. 0
- We need Antanas to speak to the NZ Branch AGM, on how it would work. 0
- More democratic way of doing things with individual votes. People do not feel involved at Branch level. This was one of the points coming out of the Special Meeting.
- Currently we rely on remits coming in on time before Region AGMs so Region can vote.
- o However people don't attend Region meetings either so there is still only a small proportion of people voting on the remits.
- Clause 8.3(3) should not be deleted. Jeanette Watson did research about "electronic means of voting" and 0 this was put into the Constitution especially to ensure it was able to happen.

Moved that: We look at all the remits together and decide whether we put forward only some remits this year.

Moved: Bill Jacob/Glenna James/ Carried

- Which remits do we want? 0
- We certainly want the university one to go ahead as it was delayed last year.
- Possibly drop the removal of MCPC remit, as it will only be merged into a new position this AGM, and we would be doing away with it before there was a chance to see if it worked.
- Do we put some out as discussion documents only and put the remit next year after seeing how other 0 **Regions feel?**
- We don't want to put a remit this year, have it rejected and resubmit next year. Resubmitting remits 0 hasn't worked in the past.
- Best practice would be to put names forward for Management Committee positions, have an open agenda 0 and strategise from there.

Moved that: We put forward all four Remits for the NZ Branch AGM to be held on 1 January 2018.

Moved: Linda Carter/Ian Stewart/ Carried (For 9 ; Against 5)

 The only way to influence the vote is to get the Remits out to all Regions as soon as possible after 31 August, which is the deadline date for remits to be received by the NZ Branch. We shouldn't wait until NZ Branch Secretary sends them out.

Moved that: The Region put in train the publicity of our Remits to other Regions to support our case, as soon as possible after 31 August.

Moved: Bill Jacob/Douglas McCartney/ Carried

• The four Remit proposers are to get the proposals to the Region Secretary as soon as possible, to forward to NZ Branch, and then to other Regions.

REPORTS:

Queen's Birthday Weekend School 2017 (Andrew Patterson)

- Overall the club feels this was a very successful school with many compliments being made by attendees to individual club members. It was very well attended with 70 dancers and musicians which may in part be due to the great advertising by committee members, Rotorua being a very centralised location plus a great tourist destination.
- The venue was great due to all the dancing classes and events being held in one location. This allowed for more socialisation at eating times etc.
- The classes all ran smoothly. The teachers were well suited for their class level and the attendees all seem to enjoy their classes and gain a great deal of confidence and competence in their dancing.
- The Rotorua Club Annual Ball was also very successful and enjoyed by about 100 dancers.
- Catering was well organised and run by Angela, supported by current and past club members. A very detailed roster helped with this.
- The club would like to acknowledge and thank our main sponsors Pub Charity. Also the extra support/help we had from other clubs; this was most appreciated and certainly contributed to a successful school.
- No financial report as yet, with some outstanding accounts still to come in.
